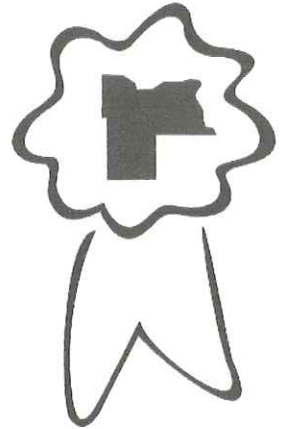

RE: Booth Space at the 2018 Mercer County Fair

1. Rental Fees:

- Inside space is \$70.00 per booth. Each booth is 8' x 10'.
- The rental fee also includes two (2) gate passes for the four (4) days of the County Fair. Payment is required with your registration.
- Please note that the rental fee is NON-REFUNDABLE.

2. Setup Times (All times are Central Time):

- Thursday – 12:00 Noon

3. Tear Down (All times are Central Time):

- Sunday – 4 pm

4. Commercial Building Hours:

- Thursday thru Saturday 12:00 pm to 9:00 pm
- Sunday 12:00 pm to 4:00 pm

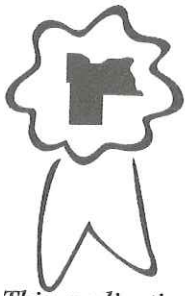
Vendor booths are located in the Beulah Civic Center Building. The exhibit area is well lit with cement floor in the exhibit area. We use pipe and drapes for the booths which are supplied with one table and two chairs. We do have electricity for most wall booths.

We are unable to furnish extra tables, tape or electrical extension cords and you will need to supply your own if those are needed. Parking will be available in the general parking lot next to the fairgrounds.

Reservations of booths are on a first come basis. We try to not double up on similar vendors and will try to limit duplicates.

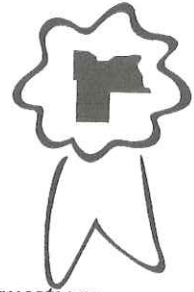
