#### **MEETING MINUTES**

Beulah Civic Center May 25, 2021, 5:30 p.m.

The meeting was called to order by President Rick Bauman at 5:32 p.m.

**Secretary's Minutes** — Donna moved to accept the emailed minutes taken by Liz Simpfenderfer. Rita seconded. Motion carried.

**Treasurer's Report** – Liz Simpfenderfer gave the treasurer's report with a balance on hand as of May 25, 2021 as \$145,098.51. Gloria moved to accept the report. Rita seconded. Motion carried.

**Correspondence:** Rita received a \$1,700 dividend check from the North Dakota Insurance Reserve Fund.

#### **Old Business:**

#### Kids Rodeo –

- Rita is working on the food options. The board decided to serve hamburgers, hot dogs and chips which would meet the Custer Health Department requirements.
- Gloria stated that the ads for the event will be in the Weekender this week and KDKT is already playing radio ads. The beer gardens will have to be in a fenced area. Board will have to determine setup for the beer garden and ticket booths.
- Rick will schedule a work day prior to the event. The board will need to hire an announcer.
   Gloria will call someone from the local radio station that may be willing for about \$300.
   Still need to hire pick-up men, rodeo clowns and emergency services. Rick will contact
   MDU to ensure electric supply is available by the beer gardens.

#### Open Livestock Show —

Tiffany will work on promoting this event after the school year ends. The event has been posted with many livestock organizations across the state and on the Mercer County Fair website. Discussed awards and backdrops for pictures. She collected \$1,300 in sponsorship but needs about \$1,500 to cover this expense. Liz motioned to cover the expense over \$1,300. Gloria seconded. Motion carried.

#### Old Business: (Continued):

#### Entertainment Update –

- Liz and Gloria reported everything is in place. They are waiting on the turkey races as they
  may or may not be able to come due to health issues. Vern will check with a petting zoo
  from Russo for a possible back up. Everything should be ready for printing next week.
- **Premium Books** Gloria received a grant to cover the cost of printing.
- Advertisement Gloria asked if they should have a one or two-page ad in the Weekender and how many posters to print. Vern moved to approve the two-page ad for \$700 and 100 posters with a QR barcode included for \$120. Liz seconded. Motion carried.
- Beer Gardens Gloria is still seeking help for Thursday night and Saturday day shift.
- Ticket Booth Helpers Gloria will begin working on the ticket booth helpers list this week.

#### Maintenance/Improvement Update –

Rick and Vern presented a bid from Weber Electric of Washburn, ND. Local electrical businesses were given the opportunity to submit bids but none were received. Discussion was held and Liz moved to accept Base 1 and Adder 1 (see attachment) for \$14,750 as stated on the estimate pending approval from MDU, City of Beulah and Mercer County Commission. Gloria seconded. Motion carried. Liz moved to accept Base 2 as stated on the estimate (see attachment) for \$2,275. Gloria seconded. Motion carried.

#### **New Business:**

- Gloria stated the Beulah Class Reunion committee is looking to hire someone to set up and take down the stage and tents they are renting from the fair board. The fair board is not interested in doing this, but they will try to find someone.
- Camping on the Fairgrounds The board determined that only vendors and board members will be allowed to camp on the fairgrounds due to space availability. Vern spoke to the City of Beulah and they may be able to reserve spots at the Sun Valley RV Park.

Rita Skraba made a motion to adjourn. Gloria seconded. Motion carried. Meeting adjourned at 7:44 p.m.
